Additional fees

- Non face-to-face support:
 - Applied to centre-based programs billed as a separate line item.
 - Provides a more accurate representation of the non-direct support provided to each individual ie tasks that are provided outside of direct support. These tasks can include, but are not limited to, handover notes, NDIS reports about progress, end of plan summary of supports, coordinating and planning an activity.
- Centre Capital Costs a standard rate as set by the NDIS to cover costs incurred to run centrebased activities billed at \$2.44 per support hour.
- Transport support Day Options bus billed at 1:3 support rate for 0.5 hours per trip.
- Transport kilometers \$0.97/km unmodified vehicle \$2.76/km modified.
